DURATION:

The appointed faculty will serve as a SLO Data Wizard for up to one year (fall 2020-spring 2021).

- Anca Husher will serve as SLO Data Wizard for both the 2020 Fall Semester and 2021 Spring semester.
- Judy Reiman will serve as SLO Data Wizard for both the 2020 Fall Semester and 2021 Spring semester.

REASSIGN TIME:

Each Faculty Member will receive 10% reassigned time each semester.

DETERMINING SERVICE:

The Senate President will conduct an open call for applicants for the SLO Data Wizards from the entire full-time faculty in spring 2020. The Senate Council and SLO Coordinator will work collaboratively to select new SLO Wizards. The Senate Council will notify the appropriate Dean and VP for scheduling purposes.
