

TIPS FOR 2021-2022 FAFSA

Create a FSA ID: WWW.FSAID.ED.GOV

- Write down username and password (even security questions) as this is an application you have to re-log into every year.
- Complete email and phone verification. If, in the future you forget the log-in information, you can easily retrieve it through either method.
- **Both student and parent will need to create FSA ID.**

FAFSA Application: WWW.FAFSA.GOV

(MUST BE COMPLETED AS THE STUDENT NOT THE PARENT)

The Save Key is an extra security measure to keep your information private. Code can be short and simple

1. **Student Demographics**: Once in the FAFSA application, double check personal information. Especially look for errors in social security number as this can be a problem if mistyped. Add the high school you WILL BE graduating from.
2. **School Selection**: Columbia College school code is **007707**. If considering other/multiple schools (up to 10) add them as well. **TIP**: if you are considering multiple schools, add the school with the highest tuition first!
3. **Dependency Status**: Read through questions carefully, answers on these questions will determine if you are considered dependent or independent. Dependents will have to include parent information.
4. **Parent Demographics**: Enter parent information and double check socials (SSN) are correct. If parents are married you will have to add both of their information, even step-parents. Make note of who is parent 1 and parent 2 as you will have to specify during the financial information and signing at the end.
5. **Financial Information**: USE IRS RETIREVAL TOOL. This will bring you to a new web page on the IRS.gov website. Most of your filing information will be there already, but you will need to add the address exactly as it appears on your 2019 taxes. Check the box “transfer my tax information,” and click “transfer now.” It will save A LOT of time.
 - a. Remaining tax information should say “transferred from IRS.” Continue through financial questions for parent, answering things that were not transferred.
 - b. Answer student financial questions, link to IRS again if student filled taxes in 2019.
 - c. If IRS retrieval tool does not pop-up, read questions carefully and enter your 2019 tax information correctly into spaces provided.
6. **Sign and Submit**: Both student and parent will have to sign the FAFSA to submit. When prompted, enter your FSA ID, which will be used as your “electronic signature.” If parent has not made a FSA ID, they will have to create one to submit the application. Once you have signed, press the “SUBMIT MY FAFSA” button and a congratulations page will appear. Then you can log out.

2. Click login.
3. Select "I am the student."
4. Click on the link "create one" and it will open the FSA website
5. Enter your username & email: _____
