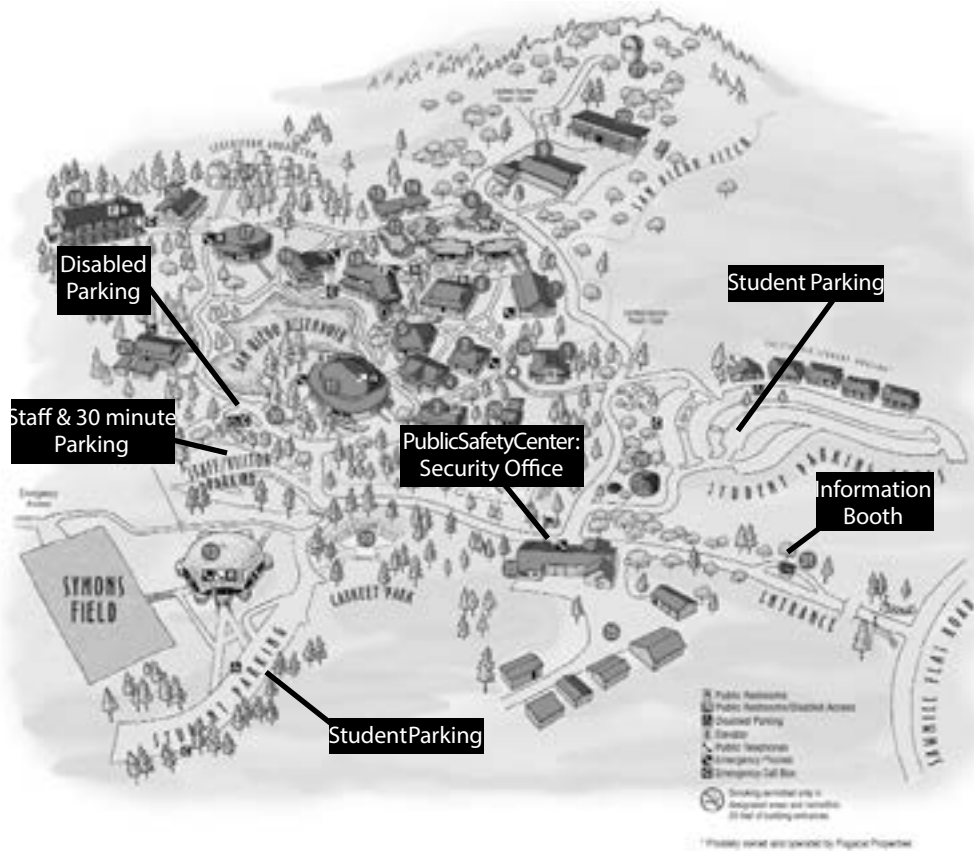

Columbia College

Campus parking regulations exist for the convenience, safety and protection of the total college community. *The Yosemite Community College District (YCCD) Parking and Traffic Ordinances* govern parking regulations on the Columbia College campus. Parking citations are issued for violation of the college's parking regulations. The full text of the *YCCD Parking and Traffic Ordinances* is available for review at the Campus Security and Business Offices.

Parking Fees & Permits

(YCCD Parking and Traffic Ordinances, Section 1500)

As authorized by California Education Code, Section 76360(a), a parking permit is required by anyone parking on campus. Semester and summer session permits are available for purchase at the college Business Office. Daily and visitor permits are available at the Information Booth located on the college access road (Columbia College Drive). A semester permit holder arriving on campus without the permit will be required to purchase a daily permit.

Daily permits may be purchased either from Information Booth staff or at the parking permit self service dispenser, when the Information Booth is closed. The Information Booth is open from 7:00 am to 6:00 pm Monday through Thursday, 7:00 am to 12:00 noon on Friday, during Fall and Spring semesters, and at other times as necessary for special events/classes. (Hours may vary due to funding limitations.)

Parking permits **must be clearly visible**, on the dash, windshield or rear view mirror.

Any unique circumstances regarding permits should be negotiated with Campus Security prior to the situation resulting in the issuance of a citation.

Parking Areas

(YCCD Parking and Traffic Ordinances, Section 1300)

Parking is permitted in **designated parking spaces only**. A campus map indicating parking areas is printed on the back of this pamphlet and is available upon request at the Information Booth.

Student parking is allowed in parking areas designated for student use only. These include the four-level main student parking lot located to the north of Columbia College Drive and the parking lot adjacent to the Oak Pavilion.

The staff parking lot is reserved for employees of the college and official, invited guests of the College only. Vehicles parked in the staff lot must display valid staff permits. Employees may purchase staff permits at the Business Office.

Parking in **disabled parking** areas is restricted *at all times* to use of persons who qualify under California Vehicle Code. Display of DMV authorized placard or license plate is required. Any unauthorized use of such area is a violation of California Vehicle Code **subject to a fine of \$275.00**.

Visitor Parking is restricted to 30 minute marked visitor parking spaces located in the Staff parking lot.

Motorcycle parking is restricted to areas designated motorcycle parking only.

Curb Markings

(YCCD Parking and Traffic Ordinances, Section 1200)

Loading/unloading is permitted in any yellow curb marked area, or where parking is not prohibited. Loading/unloading is limited to no more than a 30 minute time limit. Loading/unloading is never permitted in restricted areas (i.e. red curb zones, disabled parking areas, etc.).

Miscellaneous Regulations

(YCCD Parking and Traffic Ordinances, Section 1700)

Parking a vehicle on campus overnight, or parking at any time for the purpose of storage, repair (except for emergency repairs) or habitation is prohibited unless special permission is obtained from Campus Security.
